Dear Parents/Carers,

As we approach the start of the new term, I would like to provide an update and some reminders for the rest of the academic year. As mentioned in <u>our latest newsletter</u>, we have had a very busy and successful term!

Mobile phones

Thank you for your feedback and support following the <u>letter regarding mobile phone use</u> at school. Phones must always be switched off and placed at the bottom of their bags or in lockers. We appreciate your support in maintaining a phone free site by not phoning or messaging your child during the school day. As mentioned previously, you can contact the school office for any urgent matters.

Uniform

Uniform is a vital part of our school's identity; it brings a sense of belonging and is an outward expression of our 'Ready To Learn' values. It reinforces who we are as a community and allows our students to feel pride in their school. Towards the end of the last term, we needed to remind some students about our school uniform expectations.

Our full uniform policy can be found here; however, I would like to reiterate the following:

- Shorts and Skirts must be <u>tailored</u> and <u>knee length.</u>
 - Lycra/stretchy/sports shorts, skirts and leggings are <u>not</u> acceptable. Students will be required to change into trousers available from our uniform store.
- Students are required to wear school shoes and black socks (trainers are not acceptable)
- We expect students to have **natural hair colours** as would be expected of someone working in a formal workplace environment.
- Students may choose to wear a pair of **small sleepers** or stud earrings (**one in each ear**) in the **ear lobe only**.
- Students may choose to wear a small, plain silver, gold or clear plastic nose stud.

To confirm, the following is **<u>not</u>** acceptable

- False eyelashes, acrylic nails or any nail extensions
- Facial piercings, including nose rings, septum rings, and tongue piercings

We work closely with students and families to ensure that all students arrive in the correct uniform, including providing a uniform store full of freshly laundered or new items of clothing for students who need to borrow an item of uniform for the day.

Summer Weather

As the days are (hopefully!) getting warmer, I would like to remind you of the following:

- Students need to bring a clear water bottle each day to stay hydrated
- Students will need to take responsibility by only filling these during social times
- Fizzy drinks and energy/isotonic drinks are **not** acceptable and will be confiscated.

In a period of sustained warm weather, we will communicate with you regarding any changes to our uniform expectations.
